Insurance Chair (Cris)

- We are covered thru February 2026. Some delays getting renewed – our broker is ill and has no backup. We're having trouble getting the certificate for the February rallye. If this persists a few more days, Cris will contact K&K directly to 1) get our certificate and 2) see if we can bypass the broker. If we can't get the certificate by the February meeting we may have to delay the event until March.

Awards Chair (Eric)

- Eric will make par plaques and awards for the Feb 7 event (Wicked: For Good). He has ample supplies of magnets and lamination materials and will talk with the rallyemasters for art.
- There is a small collection of recent unclaimed awards that are indexed by name and ready to hand out at Registration.

Database (formerly Membership) Chair (Eric)
