### Insurance Chair (Cris)

- We currently do not have insurance. Our policy should run Feb 24, 2025 to Feb 24, 2026. Our liaison was told by K&K who said we were terminated on Jan 11, 2026, but would/couldn't tell us why. Likely our broker dropped the ball on something. Cris spoke to K&K and found a per-event option. Cris spoke local Parks & Rec as to permits or doing business in the parking lot. We assume we don't need coverage for the park/start location. Devon (K&K) quoted \$500 for this one-event coverage. Marcy/Esca says the insurance companies don't want to deal with the "consortium" that our previous policy was thru and would prefer to deal with individual clubs. We need Liability (\$1M min) and Errors/Omission insurance (as per our bylaws). Matt suggests we should want start/finish covered. We will meet tomorrow to decide whether to go forward with the Sat rallye.

A list of possible providers was presented:

- Eventsured — Offers instant online quotes and binding for special event insurance, including liability for various public events.
- K&K Insurance — Provides short-term event insurance; covers a wide range of activities (e.g., festivals, hunts, non-competitive events) and can handle some auto-related exposures if static or low-risk.

- Thimble Insurance — Quick general liability for events, including outdoor/public ones.
- Sadler Sports & Recreation Insurance — Specializes in event liability with online quotes; good for recreational/public activities.
- EventHelper or similar online platforms — Low-cost options guaranteed to meet venue needs if applicable.
- Travelers, Allstate (via partners), Markel (often through Hagerty for car-related), or XINSURANCE — Offer special event policies that can be tailored.

### Award Chair (Eric)

- Artwork is prepared for the par plaques and awards for the Feb 7 event (Wicked for Good). We are holding off on sticking the art to the magnets, as the event might be delayed if the insurance isn't ready.

### Database (formerly Membership) Chair (Eric)

- Eric will staff the Membership desk at the start on Feb 7, and do Registration at the same time, with help from Cris' wife Trina (much appreciated!). He will depend on others to bring the Start Box, table, chairs, etc., and to take them away at 1pm.
