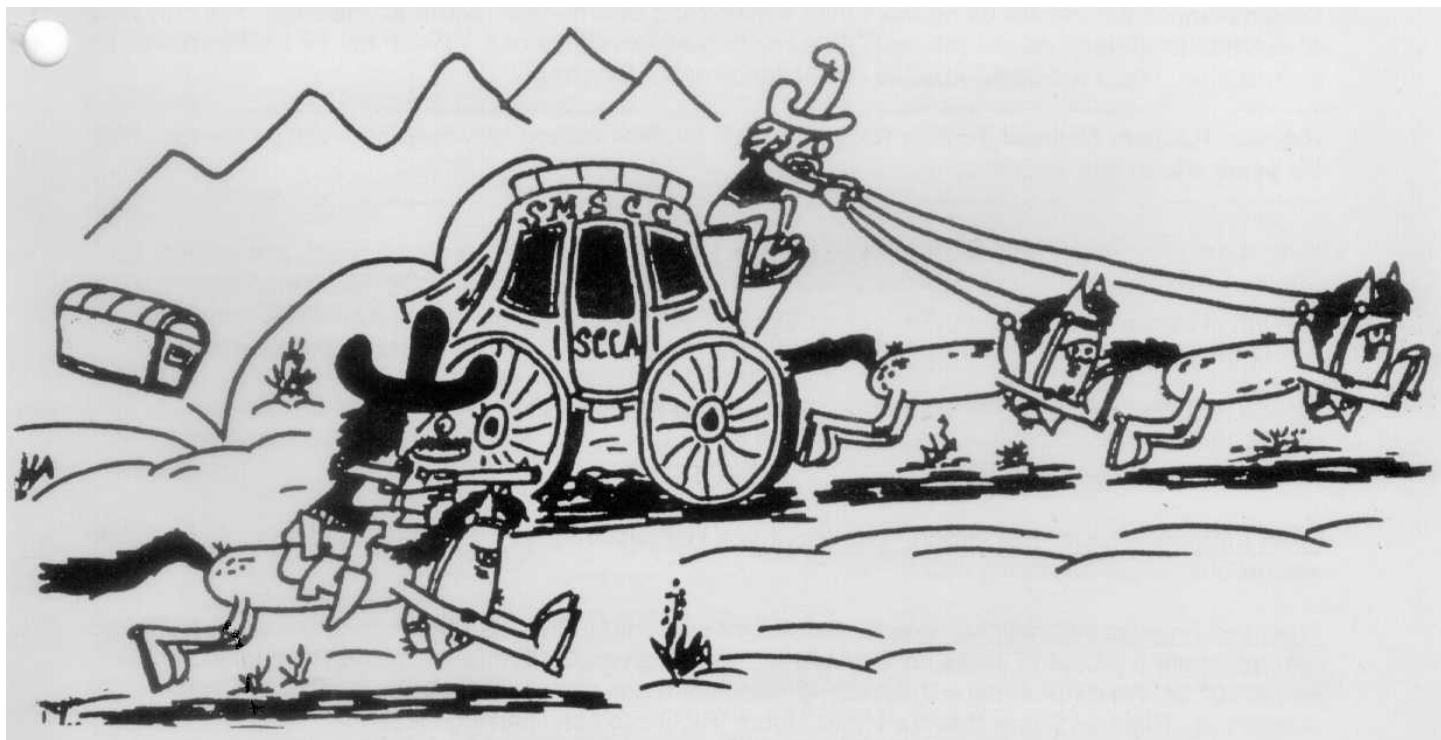

RALLY PHILOSOPHIES

Stagecoach is a traditional tour rally which travels the back roads of northern Santa Barbara County and surrounding counties. The event does use a limited amount of quality unpaved roads, usually when there is no paved alternative.

Highway Robbery travels through the foothills of California's Central Coast. *Highway Robbery* will be a course-following trap rally of average difficulty in which most contestants are expected to do most legs correctly. It utilizes variable Main Road Determinants but there will be no more than 4 main road determinants active at one time. The only type of optional route instructions will be ITIS numbered route instructions. There will be no lettered route instructions. There will be no *Aristotle* nor *Absence of the Sign* traps!

Take the Monte and Run will be a tour rally using a Monte Carlo format with passage controls. The official mileage and car zero time will be given for each potential control location, but not all such locations will be manned. This rally will finish earlier to help with your travel plans.

DIRECTIONS

From Los Angeles International Airport (LAX): Exit airport East on Century Blvd. Right/North onto Interstate 405. After 16 miles, Right/North [at Exit 63B] onto US 101 toward Ventura. After 155 miles, Right/South [at Exit 173] onto Broadway (last Santa Barbara county exit). The hotel is on the right within ¾ mile.

From Burbank/Glendale/Pasadena Airport (BUR): Exit airport East (on Thornton Ave.). Right/South onto Hollywood Way. Right on Alameda Ave and then immediately Right/West on California 134/Ventura Freeway toward Ventura. Straight/North [at Exit 1A] onto US 101/Ventura Freeway. After 161 miles, Right/South [at Exit 173] onto Broadway (last Santa Barbara county exit). The hotel is on the right within ¾ mile.

From Santa Barbara Airport (SBA): Exit airport North on Fowler Road (becomes Fairview Avenue). Right/North onto US 101. After 68 miles, Right/South [at Exit 173] onto Broadway. The hotel is on the right within ¾ mile.

From Santa Maria Airport (SMX): Exit airport East on Skyway Drive. Left/North onto California 135. After 5 miles, Left/West on Williams St. The hotel is immediately on the right.

From San Jose International Airport (SJC): Exit airport northeast on Airport Parkway. Right/Southeast onto US 101. After 215 miles, Right/South [at exit 173] onto Broadway. The hotel is on the right within ¾ mile.
