I'd wanted to do something completely different, and the results weren't quite all that they cracked up to be, but both cases were cracked in the end, and one team cracked -both-.

Overall notable results:

- 11 teams got potatoes (Glen wanted to hide a clue inside the potato and I seriously considered it, but this wasn't the Monster Mash...).
- 7 teams got the See-Krate note and the additional RI 43, and 6 teams told me they had solved zee case per its instructions, but I suspect one team did it because they saw someone else do it. Sneaky!
- 5 teams gave a Werewolf a lift, and 2 teams gave Clara a lift. Time to jump in the HOV lane!
- 4 teams correctly solved the Investigation puzzle, with several more getting partial credit
- 2 teams correctly solved the Logic puzzle, with a handful getting partial credit.
- Most teams (12) found the acrostic, but only two teams correctly left RI 40 blank.

Most of the info was found using the C-Krets that were true, but a couple of false answers were helpful too. Some of the clues were redundant on purpose.

RI	Relevant to the Logic Puzzle?	Notes
4	No	We establish that Kris's last name is Gavello, which is more for the Investigation puzzle.
5	Yes	Because this is a -false- answer, we know that Rosa was not at the Golden Gate Bridge in SF.
8	No	Similarly, now we know Justin's last name is Timberpine and he's a werewolf.
9	Indirectly	Rosa is an alchemist so she can mix things.
12	Yes	Justin is a werewolf, so he can't have the dagger (we put an X in Justin/Dagger
15	Yes	Sumac Soda can be purchased at the Fair, so put an O there. And Xs in the other spots vertically and horizontally because no other Weapons can be at the Fair.
21	Yes	Justin has the Oleander lotion. Add an O to Justin and Oleander. You can also add Xs to the other spots because Justin can't have any other weapon.
23	Yes	Whoever wanted to win the Valerian Contract can be found at the Grand Terrace. Add O to Valerian and Grand Terrace and Xs in the other spots.
24	Yes	Since this is a false answer, the Mahogany Bat is -not- at the Fair. (But we already knew that from 15.)
CP 1	Yes	 The person using Oleander cream wanted to be popular. And since we know that was Justin, that fills in the Motive for him. The person who owned the Mahogany Bat's listed
	165	address is the Ponderosa Ranch. Means that the person who wanted to save the Ponderosa has

		the bat, so you can fill in the rows and column for that.			
26	Yes	The Silver Tip Dagger can't be found at the Fair. (This is backup in case you missed the other two and also as camouflage so you couldn't deduce the puzzle from the RIs.)			
29	Indirectly	Subtle; the Oracle made a blonde person mix a batch of poison. Since we already ruled out Justin, and we know that Kris has white hair, and Evelyn looks like Jackie O (who has dark hair), that leaves Rosa, the Alchemist who was compelled by the Oracle.			
35	Yes	False answer, so Kris -doesn't- want to be popular.			
36	Yes	Ties Kris to the Ponderosa, which means he has the Mahogany Bat.			
37	Yes	False answer, so the person who wanted to save the Ponderosa was not at the Miramar Airport. We know that this is Kris, so Kris is not at the Airport.			
38	Yes	Viscous = sticky, which points to the Sumac Soda. Now we know the murderer is Rosa. You might think this also could apply to Justin with the Oleander Lotion, except his motive is to be Popular.			
42	Indirectly	Added because one of the precheckers suggested it, but works with 29.			
Extras X1 X2	Yes Slightly	 Extra 'known true' hints were available at the finish line. Kris Pringle was at the Golden Gate Bridge. The person who wanted to save the Ponderosa was not at Grandview Terrace. (But we already knew it was Kris.) 			
X3	Slightly	We already know Kris had the Mahogany Bat at the Ponderosa. (X2 and X3 provided in case you got things wrong.)			
X4	Yes	Since we established Evelyn has the knife, she wants to win the Valerian contract.			
X5	Somewhat	The Oracle's agent can't be at the Airport. But we already figured out Rosa was at the Fair, right?			
X6 X7	Slightly Yes	Confirms Justin, Oleander, Popular.			

EO - Evelyn Onassis wanted the Valerian contract. Concurs with X4.
